From The President

The Value of Attending the TTCF Meetings

s a new member to the Texas Trauma Coordinator's Forum (TTCF), or you may have been asked by your boss during these financially challenging times where travel budgets are being scrutinized very carefully ... "what is the value of attending the TTCF and state meetings"? Fortunately, there are several good answers to this question. The value of attending the Texas Trauma Coordinator's Forum is networking, education, and having a direct impact on Texas Trauma rule revisions and/or creation.

First let us address networking. Each quarter there is an average of 90 Trauma Coordinators attending the TTCF meetings. The attendees include nurses from Level I, II, III and IV Trauma Centers with various degrees of tenure and maturity in their positions. So if you are a 'new' coordinator, there are many experts at the meeting eager and willing to help you with any questions or issues you are having. Remember ... we were ALL new coordinators at one point and time, so helping each other is one of the stronger values found in the organization.

Now, what about education? A goal for February, May, and August TTCF meetings is to provide two educational presentations at each meeting. Typically, there is no educational offering at the November meeting because there is a one-day nursing education track available during the annual EMS conference.

The intent for the two educational offerings is to offer one 'administrative' type presentation and one 'clinical' type presentation at each meeting. Examples of previous administrative offer-

ings include the development of trauma team activation fees, disaster preparedness, pediatric audit filters and trauma systems processes. Examples of clinical offerings have

included CT vs. DPL vs. FAST, military trauma processes, and traumatic brain injury.

And finally, how do you have a direct impact on rule revisions and creation? First, let me explain the Governor's EMS and Trauma Advisorv Council (GETAC). This is a group of EMS/trauma/acute care providers and consumers appointed by the Governor of Texas. This Council several standing committees: one of which is Trauma Systems. Every three-tofour years the Trauma rules have to be reviewed at the State level. Typically, the Department of State Health Services (DSHS) will provide "draft" revision recommendations to the rules based on activities and conversations occurring since the last rule revision. The TTCF Level III and/or the Level IV sub-committees will have opportunity to review these rule recommendations. If you individually have issue(s) with a rule recommendation then speak up ... likely someone else has the same issues. So hypothetically,

suppose the TTCF Level IV subcommittee votes as a group to oppose/ change/support a

recommended rule revision. Then historically the main TTCF body has supported the Level IV group's recommendation. The issue is then presented from the TTCF group to the GETAC

Trauma Systems group, who place heavy value on the opinion of the TTCF on a "trauma" issue. The GETAC Trauma Systems group will then communicate the issue to the

GETAC Council who place heavy value on

the opinion of the GETAC Trauma Systems group on a "trauma" issue. Then GETAC will provide their Council's "advice to the DSHS on the issue that YOU presented. See ... you CAN directly impact the rule making process in Austin.

As you can see, there are many advantages and benefits to attending the Texas Trauma Coordinator's Forum. In closing, the final point I would like to communicate is that TTCF needs YOU!!! Our group has a lot to offer, but at the same time it is a volunteer organization. Chances are you were offered the role of Trauma Coordinator at you hospital because you are a "do'er" ... The TTCF will only remain a successful and productive organization as long as "do'ers" like yourself regularly attend and participate. Hopefully, YOU will someday be one of those tenured/mature Trauma Coordinators at the meeting to help the new member.

There were 20 people in attendance at the Registry subcommittee in May.

DSHS was unable to attend the meeting but the committee wants to send out a survey monkey to establish how many registrars are out there in our State.

The committee also discussed the educational topics that members would be interested in learning this year during meetings. There was an interest in having the State come in to educate the members on how the data that is submitted is actually used as well as some other pri-

orities.

A proposal was made to have a Registry blog on the TTCF website to help disseminate information to those who cannot attend the meetings in Austin.

Several request were made to have an ICD9 coding/AAAM education class intermittently in the Registry Committee meetings. Because the AAAM information is patented, there is no way of teaching this class without bringing in their own instructors.

The ATS has an on-line course for Registrars to help enhance education/training opportunities.

GETAC will be giving an update on the status of the State Registry. As it stands, the registry work group has enough members right now and is currently not asking for new members.

The discussion was opened up by the co-chair about having the Level III/ VI facilities separating from the Level I/ II's during the registry break out sessions but majority of the members felt that all of the information needed to be giving all at once to keep everyone informed of what would be going on thru out the Trauma world.

Injury Prevention Committee

The Injury Prevention (IP) Committee Chair from TTCF met with GE-TAC on April 29, 2011 to discuss the collaboration of TTCF, TETAF, and GE-TAC regarding injury prevention activities.

The idea that TTCF would like access to evidence-based programs for which TTCF members can use was strongly encouraged at this meeting from the IP TTCF committee chair.

The committee chair stressed to GETAC that

TTCF consists of trauma coordinators who will be responsible for getting the message to the public. This was the injury prevention committee's main objective during the May TTCF meeting.

Other issues discussed included other fall prevention strategies and available programs. Two handouts were dispensed to the committee regarding falls, as well as a fall self-assessment tool. Based on the 2009 data from DSHS falls rank number 1 as the 5 lead-

ing causes of injury hospitalization. MVCs were second, followed by suicide/self-inflicted, accidental poisoning, and assaults were last.

Since May is National Trauma Awareness month TTCF is encouraging its members to develop a fall prevention program within each member's RAC, trauma center, or EMS agency.


Texas State EMS Conference 2010: TTCF Nurse Track

Trauma Survey Etiquette Brenda Putz, RN

Do you ever wonder what you should do for your trauma surveyor when they visit your facility?

Here are a few do's: Offer your assistance or recommendations with lodging. They don't know your area or a convenient, appropriate hotel.

Offer to pick them up at the airport and transport them to and from your hospital. If the airport is many miles away, it is ok if you don't. They will rent a car.

Make sure everyone knows what time to start and are

Make sure everyone knows what time to start and are there on time. Do ensure your TMD, other physicians, your administrators and key directors in trauma care are there. This is a hospital wide program. Demonstrate that by including the other department directors in this opening meet-

ing. It demonstrates hospital commitment.

Again, at the exit interview your TMD and your administration at the least should be there to demonstrate commitment. Inform the front desk in the lobby who is coming and who to call. Make sure they know who you are. Meet your surveyor at the front desk/lobby and escort them to the meeting room. During the facility walk through, you and your TMD should be available to the surveyors. You will accompany the nurse on the walk through. Your TMD will accompany the physician. If you only have a nurse surveyor, then you both should be available during the walk through. If the TMD is not

needed, the surveyor will

tell him/her.

ment directors in advance you will have a VIP touring. They need to ensure they and one of their staff members is available. As with any guest, have coffee, water or other beverages available for the surveyor in the review room or take a few minutes to show them where they can purchase. Finger foods, sandwiches, fruit, and cookies, whatever you choose, should be available for lunch. Show them the nearest restroom as well. You don't want them wandering your halls.

At the end of the survey, please escort your surveyor/s to the front lobby and/or offer them a ride to the airport.

n 2009 I was a charge nurse in the ED when I was told that management was pursuing a trauma designation. The ED director told me that this would create a new position - Trauma Coordinator. Sensing an exciting new challenge, I decided to enter my horse into the race. Well. What an exciting gallop it has been.

It all began innocently enough. As I was setting up my office - a windowless one with the only view being that of the restrooms - I was given the names and numbers of a few contacts. I started calling everybody and anybody, from fellow neophytes to seasoned veterans, hoping to get as much input as I could. Trapped in my cubbyhole day after day - making calls, read-


ing emails, and making a men-

tal note of how often some people use the restroom - my manager said that I appeared to have come under the spell of a mighty force. Fortunately, this mighty force was mighty helpful. As days turned to weeks, winter turned to spring, and I lived in fear of being crushed by a falling mountain of paper, I began to see a light at the end of the tunnel. One recently designated hospital invited me to tour their ED and pick their brains (something you really want to be clear about when touring a trauma center). This proved to be a tremendous help in alleviating those doubts and fears as we moved towards the "Big Day" - survey day.

My daily schedule was filled with meetings, meetings, and more meetings. I attended RAC, ZONE, and committee meetings. I even started hosting my own meet-

ings to recruit others. I was able to shed my long-standing belief that state agencies were really just computer with a neverending succession of voice-mail messages - I contacted DSHS and they actually have caring, helpful humans. I joined Texas Trauma Coordinator's Forum, an organization that has members with various levels

of experience who are pursuing the same goals. It has provided me with a myriad help. It's also a good excuse for an occasional out-of-town trip. The Texas Trauma Coordinators on Yahoo Groups is also a fantastic source. As I began living and breathing all things trauma, my ED director was concerned that I joined some type of cult. I told her it's not a cult, it's TCCF.



As the "Big Day" approached I learned that the

judge would be one of my fellow "cult" members. The survey day was nerve wracking nonetheless, but in the end the hospital was recommended for trauma designation. Even with the "Big Day" now in my rearview mirror, I continue to learn more everyday. And I love it! I am so thankful for all of the help and encouragement that I received along the way. I learned many things and feel as though I have increased my abilities as a nurse to help even more people. It has also been an eye-opening experience that gave me a new perspective on life. No longer do I pull the seatbelt under my left arm, or drive with my knees while fixing my hair, and the sign on my office door reads "Honk if you love Jesus. Text while driving if you want to meet him!"

Membership is open to anyone interested in improving care for trauma patients. Meetings of the TTCF are held quarterly and provide an outstanding opportunity to network with Trauma Coordinators and Trauma Program Managers from throughout Texas. During meetings, members receive updates on legislative issues, injury prevention programs, trauma registry requirements, and rule changes.

TTCF HISTORY

In 1991, Trauma Coordinator positions were added to several facilities providing trauma care in the Dallas area. This was a new, largely undefined role whose benefit was unclear. Institutional support and structure for the role was nonexistent.

Several Dallas Coordinators began meeting together for lunch to share ideas and support. Soon, Coordinators from Forth Worth began attending the lunches as well.

By early 1992, the group expanded into north Texas. The original membership expanded to eleven. These eleven individuals formalized the original trauma coordinators group under the North Texas Division of the American Trauma Society. Membership soon leaped from eleven to twenty-five, to over one hundred by mid-1992.
